What's New? The IREx Onboarding Tab

About The IREx Onboarding Tab

• **Goal**: To allow the sIRB and Lead Study Team/Study Manager (LST/SM) to share supplemental documents or guidance to help PSites complete their local submission and initiate the reliance process.


• Why do PSites need these documents?

- PSites receive single IRB instructions from IREx when contacted about a study
- PSites access the lead site approval (protocol, consent template, etc) by logging into IREx
- But sometimes sites need extra guidance or other documents that aren't in the lead site's 'approval' documents

• Sample Document Types:

- Single IRB Instructions (generated by IREx or uploaded by the sIRB)
- sIRB SOPs/Communication Plans
- Consent form instructions
- Template consents/Part 2 Consent (if an sIRBs does not share with the lead site's initial approval)
- Released May 2024




2024 Q2 Metrics Update

- 92% of sites in IREx have completed their Institutional Profile
- 88% of IREx sites have indicated reliance
- 87% of sites have ceded review and have approval posted to IREx
- 33 out of 46 single IRBs are using IREx for more than one study
- **12** median days from initial sIRB submission to sIRB approval for relying sites (*not including local review time*)

2024 Q2 Metrics Update

- **512** unique participating sites
- 4076 total reliances across all studies
- 7 sites per study on average
- 85% of studies created after 2018 collecting local considerations
- 33 days between lead site initial approval to submission (median)





Satisfaction Surveys April-June 2023

Satisfaction Survey: Methods & Response + Rates

0

• WHO to survey

- For the **sIRB**, survey sent to the Primary Contact listed on the study
- For the **Relying HRPP**, survey sent to the Relying HRPP contact who signed the HRP Survey
- For the LST/SM, survey sent to the most active member-based a) email interactions or b) the person listed most frequently in the log
- We did not contact potential respondents >2 times, even if they were eligible

• WHEN to survey IREx users

- **sIRBs** surveyed after lead site approval posted to IREx
- Lead Study Teams (LST)/Study Managers (SM) surveyed after ~25% of their PSites received initial approval
- Relying HRPPs surveyed after receiving initial approval on a study

Survey Completion by Respondent

- **sIRBs**: 6 completed/15 sent; 40% response rate
- LST/SM: 20 completed/40 sent; 50% response rate
- Relying HRPPs: 22 completed/55 sent; 40% response rate

sIRB Feedback

- Both sIRB and LST reported that they:
 - Add/remove sites
 - Upload initial approval
 - Grant site access
 - Export local considerations
- Most common difficulty factor: educating lead study team

- Tasks reported as easy
 - Completing IP
 - Using getting started checklist

- Indicate required reliance agreements
- Confirming SSRP

How satisfied are sIRB users?

+

- 4/4 respondents who reported having to use admin support were very satisfied
- 5/6 respondents were satisfied/very satisfied with IREx for their study
- 5/6 respondents reported IREx made their role easier/significantly easier
- Majority of respondents said using IREx takes less time than for studies where IREx is not used

When is IREx a good fit?


- 5/6 reported they use IREx when they feel a study is a good fit
 - At least 4-5 sites
 - Appropriate site type (e.g. primarily CBOs relying = not a good fit)
 - When participating sites are already using IREx

"We suggest to study teams to use IREx if they have 4 or more sites for their study to alleviate the email back and forth to document reliance and provide study teams with **one location to easily see all of the site information**.

We have had a few of our larger study teams and consortiums begin to use IREx within the last year. They have indicated that they can't imagine having to do the reliance process any more through email like they had in the past. One consortium has multiple studies that have a minimum of 10 sites for each study."

IREx is used for studies of all sizes!

Study Size by Year Study Created




How satisfied are Study Managers?

- 85% of respondents reported:
 - Being satisfied/very satisfied with using IREx for their study
 - IREx made role of LST easier
 - Would recommend other LSTs use IREx
- 60% of respondents reported that IREx takes the same or less amount of time as studies that do not use IREx

Sticking points for SMs


- Most commonly reported factors that make IREx difficult to use
 - Getting sites to compete their steps in IREx
 - Local site variation in process for relying on an sIRB
 - Resistance from site HRPPs
- Difficulties with the way approvals are organized and uploading studywide/site-specific amendments

Relying HRPPs

+

- 73% of respondents reported their institution is a relying site on 50+ studies
- 86% reported using IREx made their steps easier
- 90% of respondents **satisfied/very satisfied** with using IREx
- Difficulty factor: helping the study team use IREx or its resources, communication with study teams

How easy are relying HRPP tasks?



Requested Features / Comments

Feature Request/Comment	Addressed?
Allow study teams to be responsible for several elements of the questionnaires – such as uploading consent forms	Yes
Site staff being able to register themselves; being able to share study documents with sites once they are registered to the study (protocol, SIRB study approval	Yes
[As the LST, when initially adding sites and study contacts,] Adding other coordinators to IREx for each of our sites would be helpful	Yes
We'd like the local context forms to be editable through the life of the study as amendments are added	Yes
Providing cover letters and steps to send to sites to know how to complete reliance and submit to the sIRB for approval. Even if the site's HRPP is familiar with IREx, many study coordinators are not familiar with the process especially with study coordinator turn over	Yes

Requested Features / Comments

Feature Request/Comment	Addressed?
SSRP cannot be revised by relying institution, which leads to a lot of discussion off-line and requests to make edits with the reviewing IRB admin - oftentimes delaying the reliance process	Not yet
Perhaps have a way early on to include local study ID#	Not yet
Make linking sites easier to understand - especially if a site has previously been approved then wants to add an additional site (or remove).	Not yet
Frequency of email notifications (more vs. less)	Not yet




- Continue working on solutions for suggestions/comments
- Continue integrating satisfaction/feedback mechanisms into IREx
- Evaluate whether using IREx reduces approval times compared to studies that DO NOT use IREx
