


2024 Metrics Update

- 92% of sites in IREx have completed their Institutional Profile
- 88% of IREx sites used IREx to rely on a sIRB
- 88% of sites have made it through the sIRB process and received initial approval
- 13 median days from initial sIRB submission to sIRB approval for relying sites (not including local review time)






